The acquisition of shares has been made through open market purchases.

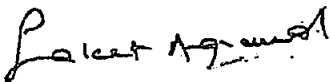

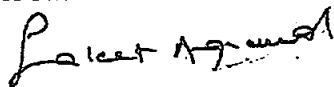
